Program Description

The VONJO Copay Assistance Program* is for eligible patients with commercial prescription insurance. Patients may **pay as little as \$25 per prescription fill**, and may receive up to a **maximum benefit of \$25,000 for a twelve-month period**.



Eligibility Requirements and Restrictions



Patient must reside in the **United States or a US Territory**



Patient must have **commercial prescription insurance**



Patient must be **18 years of age or older**
