Hard, oblong, opaque, gelatin capsule with scarlet cap and gray body, printed with "Pacritinib 100 mg" on the cap and "C78837" on the body

Storage and handling

Store at room temperature, below 30°C (86°F). Keep the bottle tightly closed and protect from light. Store in original package. Dispense in original package or in a light-resistant container.

Dosing

The recommended dosage of VONJO is 200 mg orally twice daily, with or without food. Swallow capsules whole—do not open, break, or chew capsules.

VONJO Connect™ offers access and reimbursement support to help patients access VONJO® (pacritinib). VONJO Connect provides information regarding patient insurance coverage and financial assistance information that may be available to help patients access VONJO. VONJO Connect can:

- Evaluate a patient's insurance coverage, including benefits investigation, prior authorization, and appeal support
- Assist with understanding payer requirements
- Identify potential financial assistance options that may be available to help patients with financial needs

Patient assistance offerings

- The **VONJO QuickStart Program,†** which provides a limited supply of VONJO, at no cost, to eligible, new patients experiencing an insurance-related delay in coverage
- The **VONJO Bridge Program,†** which provides a limited supply of VONJO, at no cost, to eligible patients experiencing a gap in coverage for VONJO
